John also discussed working with Nassau Community College and Hofstra University on classroom training and online training. Other Colleges and Universities as well. Our new normal is virtual planning.

Dawn Nolan from Nassau Community College discussed interactive style of training remotely and putting together remote classes for Adults dislocated worker and youths. Re: remote instructions for career, college readiness, etc.

John Sarcone announced budget transfer from Adult Program to Dislocated Workers. Budget amount transfer was \$105,000. John asked for a motion to call for a vote to pass the transfer. Walter Markowitz Ed.D Hofstra University initiated the motion and Maria Frey 2nd the motion and a unanimous vote was passed to transfer the funds.

Regina Zara and David Turner from SIEMENS discussed working with municipalities, schools, colleges, and hospitals on Long Island regarding COVID-19, their Ecosystem approach, and returning to new conditions following guidelines regarding COVID-19.

Maria Frey discussed Job Search online and programs for all Job Seekers, working on videos, and created Linkedin - 5 plus Boot Camps. She has received 100 percent support from her former sponsors.

Sunita Manjrekar Director of Nassau County Department of Social Services (NCDSS) discussed Nassau County status updates and stated that NCDSS has been inundated with applications regarding food stamps, childcare issues, etc. She said It has been challenging working with half their workforce, however NCDSS is doing the best they can dealing with many issues that arose from COVID-19.

Jennifer Pravato mentioned she spoke to some people who have lost their jobs, and most were successful in finding new jobs on LinkedIn.
