SYSTEM PARTNER AGENCIES AND SERVICES

☐ The Workforce Partnership (TWP) (516) 797-4560

The Workforce Partnership (TWP) offers a system of workforce services such as evaluation of skills, job search assistance, career counseling, veterans' services, resume development, job-preparation/computer workshops, labor market information, occupational training, internet access, job-referrals, and on-site recruitment events with local companies.

☐ New York State Education Department, Long Island Regional Adult Education Network (LI-RAEN) (934) 420-2850

The Long Island Regional Adult Education Network (LI-RAEN) provides access to literacy programs, for adults age 18 and older. Assists adults to become literate and obtain the knowledge and skills necessary for employment; assists adults in attaining a high school equivalency diploma and in preparing for college or other types of job training; and, assists immigrants and other individuals to learn English.

☐ New York State Department of Labor (NYS DOL) (516) 934-8532

The New York State Department of Labor (NYS DOL), Division of Employment and Workforce Solutions, provides quality training, job search, and job matching assistance to meet the needs of job seekers. NYSDOL offers employment and training services to unemployed veterans; supports workers whose jobs move outside of the United States; and, offers Unemployment Insurance to eligible workers.

☐ New York State Education Department, Adult Career and Continuing Education Services – Vocational Rehabilitation (ACCES-VR) (516) 227-6800

Adult Career and Continuing Education Services-Vocational Rehabilitation (ACCES-VR) provides services to individuals with disabilities to obtain employment through training, education, rehabilitation, and career development. Services include vocational counseling and guidance, evaluation of skill-sets, occupational training, job-preparation services, and job placement. ACCES-VR also provides job coaching for those individuals who would benefit from a staff person teaching them their job duties, one-on-one, at the worksite.

☐ New York State Commission for the Blind (NYSCB) (516) 743-4188

The New York State Commission for the Blind (NYSCB) works with individuals of all ages who are legally blind to help them live independent lives by providing counseling, training, and employment services. Programs offered to job seekers include assessment of skills, skills training, work try-out, on-the-job training, and job coaching for those individuals who would benefit from the support of staff to teach them new job tasks at their place of employment. Staff of the Commission for the Blind will also advise the visually-impaired of other services or accommodations which would help them better perform their job.

☐ Port Washington Community Action Council, Inc. (516) 883-3201

Provides support services, basic needs and advocacy to low-income residents. Also, operates a food pantry.

☐ Urban League of Westchester County – Senior Community Service Employment Program (SCSEP) (516) 464-4560

The Urban League of Westchester County helps unemployed, income-eligible job seekers, age 55+, gain valuable work experience through a work-based job training program. Participants are placed in temporary employment opportunities, earning minimum wage.

☐ Nassau County Department of Social Services (NCDSS) (516) 227-8519

The focus of the Nassau County Department of Social Services (NCDSS) is to provide financial assistance, supportive services, and work opportunities to eligible residents of Nassau County, with the goal of assisting recipients in obtaining gainful employment. NCDSS programs include: Temporary Financial Assistance, Supplemental Nutrition Assistance Program (SNAP) to help needy families purchase healthy and nutritional foods, Home Energy Assistance Program (HEAP) to assist low income people pay the cost of heating their homes, assistance in finding employment, child support payments, child care assistance, as well as, child and adult protective services.

☐ Nassau Community College (NCC) (516) 572-7126

Nassau Community College, through a grant awarded under the Carl D. Perkins Act, helps develop more fully the skills of students who elect to enroll in Career and Technical Education (CTE).
